  4. In the event of the inability or refusal of the Trustee herein named, to act, the Successor Trustee shall have the

same powers and authority pursuant to the terms of the trust agreement as is vested in the Trustee named herein.

All of the covenants, conditions, powers, rights and duties vested hereby, in the respective parties, shall
