THIS INDENTURE, made this 13th day of March, 1973, between LaSALLE NATIONAL BANK, a national banking association of Chicago, Illinois as Trustee under the provisions of a deed or deeds in trust duly recorded and delivered to said bank in pursuance of a Trust Agreement dated the 8th day of April, 1969, and known as Trust Number 39370, party of the first part, and Burton Novak and Judith A. Novak, his wife, as joint tenants, and not as tenants in common, parties of the second part,

WITNESSETH, that said party of the first part, in consideration of the sum of Ten Dollars, and other good and valuable considerations in hand paid, does hereby grant, sell and convey unto said parties of the second part,

the following described real estate, to-wit:

Unit 8-B as delineated on survey of the following described parcel of real estate (hereinafter referred to as "Parcel"): Lots two (2) and three (3) in E. P. Brosseau's Resubdivision of all of the part lying West of Lake View Avenue of Lots twenty one (21), twenty two (22), twenty three (23), and twenty four (24) in Culver's Addition to Chicago, being a subdivision of the South quarter (30) Rods of the North sixty (60) Rods, also the South quarter of the North East Quarter of the North West quarter of Section twenty eight (28), Township forty (40) North, Range Fourteen (14), East of the Third Principal Meridian, in Cook County, Illinois, which survey is attached as Exhibit "A" to Declaration of Condominium Ownership made by La Salle National Bank, a National Banking Association, as Trustee under Trust Agreement dated April 8, 1969 and known as Trust No. 39370, recorded in the Office of the Recorder of Cook County, Illinois, as Document No. 21785692; together with an undivided 1.8084% interest in said Parcel (excepting from said Parcel the property and space comprising all the units thereof as defined and set forth in said Declaration and Survey) situated in the City of Chicago, County of Cook and State of Illinois.

Party of the first part also hereby grants to parties of the second part their successors and assigns, as rights and easements appurtenant to the above described real estate, the rights and easements for the benefit of said property set forth in the aforementioned Declaration, (and party of the first part reserves to itself, its successors and assigns, the rights and easements set forth in said Declaration for the benefit of the remaining property therein.) This Deed is subject to all rights, easements, restrictions, conditions, covenants and reservations contained in said Declaration the same as though the provisions of said Declaration were recited and stipulated at length herein.

- Private, public and utility easements of record.
- Encroachment of the building over the South line into Barry Avenue to .59 feet.
- Party wall rights and agreements, if any.
- Acts done or suffered by Purchaser.

This deed is executed by the party of the first part pursuant to and in the exercise of the power and authority granted to and vested in it by the terms of said Deed or Deeds in Trust delivered to it in pursuance of the Trust Agreement above recited.
