Leave to enforce said judgment is granted instanter. Execution to issue. The remaining counts are dismissed without prejudice. The City will agree to a payment plan and JOSE LUIS ARM INTA ROMAN may make interim payments on this judgment.
- JOSE LUIS ARMENTA ROMAN shall make payments by certified check or money order payable to "City of Chicago." If
  payment is mailed it must be postmarked on or before the above date and sent to:

- 3. Defendant(s) JOSE LUIS ARMENTA ROMAN and his/her/its/their heirs, legatees, successors, and assigns shall:
  - i. bring the subject premises into full compliance with the Municipal Code of Chicago by 7/28/2023;
  - ii. schedule, permit and be present for an interior and exterior inspection of the subject premises with the Department of Buildings to allow the City to verify compliance with the terms of this Agreed Order by 7/28/2023. Defendant shall call Inspector Rosado at (312) 743-0411 or (312) 743-7256 to schedule this inspection.
  - iii. Defendant(s) shall follow the compliance schedule set forth above and shall be subject to fines of \$500.00 per day for each violation of the Municipal Code of Chicago that exists past the due date. Such fines shall be calculated from the first day Defendant(s) violate(s) the compliance schedule, and shall continue to run until Defendant(s) bring(s) the violation(s) into compliance.

- 7. This matter is hereby taken off call by agreement of the parties, without prejudice, subject to the provisions agreed to and detailed above.
