THIS ASSIGNMENT OF LEASES AND RENTS ("Assignment") made as of the 29 day of August, 2022, by ARI LIFSCHUTZ, an individual, a resident of the State of Illinois, having an address at 1421 N. Wood Street, Unit 2, Chicago, IL 60622, and ADRIAN AMRINE, a resident of the State of Illinois, having an address at 1421 N. Wood Street, Unit 2, Chicago, IL 60622, as assignor (collectively "Grantor") to CITIZENS BANK, having an address at 300 Broad Street, Elizabethton, TN 37644, as assignee ("Lender").

RECITALS:

Borrower (as hereinafter defined) by its execution of that certain Note (as hereinafter defined) of even date herewith given to Lender and is indebted to Lender in the principal sum of NINE HUNDPED FORTY TWO THOUSAND TWO HUNDRED AND NO/100 DOLLARS (\$942,200.00) in largeful money of the United States of America as evidenced by that certain U.S. Small Business Administration Note made by PROJECT SKIN LLC, an Illinois limited liability company, (hereafter the "Borrower") (together with all extensions, renewals, modifications, substitutions and amendments thereof, the "Note"), with interest from the date thereof at the rates set forth in the Note, principal and interest to be payable in accordance with the terms and conditions provided in the Note.

Grantor desires to secure the payment of the Debt (defined below) and the performance of Borrower's obligations under the Note and any other obligations set forth in the loan documents evidencing the Debt.

ARTICLE 1- ASSIGNMENT

- Section 1.1 <u>PROPERTY ASSIGNED</u>. Grantor rereby absolutely and unconditionally assigns and grants to Lender the following property, rights, interests and estates, now owned, or hereafter acquired by Grantor:
- (a) <u>Leases</u>. All existing and future leases affecting the use enjoyment, or occupancy of all or any part of that certain lot or piece of land located at 1421 N. Wood Street, Unit 2, Chicago, IL 60622, as more particularly described in <u>Exhibit "A"</u> annexed hereto and made a part hereof, together with the buildings, structures, fixtures, additions, enlargements extensions, modifications, repairs, replacements and improvements now or hereafter located thereon (collectively, the "<u>Property</u>") and the right, title and interest of Grantor, its successors and assigns, therein and thereunder.
- (b) Other Leases and Agreements. All other leases, subleases and other agreements, whether or not in writing, affecting the use, enjoyment or occupancy of the Property or any portion thereof now or hereafter made, whether made before or after the filing by or against Grantor of any petition for relief under 11 U.S.C. 101 et seq., as the same may be amended from time to time (the "Bankruptcy Code") together with any extension, renewal or replacement of the same, this Assignment of other present and future leases and present and future agreements being effective without further or supplemental assignment. The leases described in Subsection 1.1(a) and the leases and other agreements described in this Subsection 1.1(b), together with all other present and

future leases and present and future agreements and any extension or renewal of the same are collectively referred to as the "Leases".

- (c) Rents. All rents, additional rents, revenues, income, issues and profits arising from the Leases and renewals and replacements thereof and any cash or security deposited in connection therewith and together with all rents, revenues, income, issues and profits (including all oil and gas or other mineral royalties and bonuses) from the use, enjoyment and occupancy of the Property, whether paid or accruing before or after the filing by or-against Grantor of any petition for relief under the Bankruptcy Code (collectively, the "Rents").
- (d) <u>Bankruptey Claims</u>. All of Grantor's claims and rights (the "<u>Bankruptey Claims</u>") to the payment of damages arising from any rejection by a lessee of any Lease under the Bankruptey Code.
- (e) <u>Lease Guaranties</u>. All of Grantor's right, title and interest in and claims under any and all lease guaranties, letters of credit and any other credit support given by any guarantor in connection with any of the Leases (individually, a "<u>Lease Guarantor</u>", collectively, the "<u>Lease Guaranties</u>"). The "<u>Lease Guaranties</u>" to Grantor (individually, a "<u>Lease Guaranty</u>", collectively, the "<u>Lease Guaranties</u>").
- (f) <u>Proceeds</u>. All proceeds from the sale or other disposition of the Leases, the Rents, the Lease Guaranties and the Bankruptcy Claims.
- (g) Other. All rights, powers, privileges, options and other benefits of Grantor as lessor under the Leases and beneficiary under the Lease Guaranties, including without limitation the immediate and continuing right to make claim for, receive, collect and receipt for all Rents payable or receivable under the Leases and all sums payable under the Lease Guaranties or pursuant thereto (and to apply the same to the payment of the Debt or the Other Obligations), and to do all other things which Grantor or any lessor is or may become entitled to do under the Leases or the Lease Guaranties.
- (h) Entry. The right, at Lender's option, upon revocation of the license granted herein, to enter upon the Property in person, by agent or by court-appointed receiver, to collect the Rents.
- (i) <u>Power of Attorney</u>. Grantor's irrevocable power of attorney, coupled with an interest, to take any and all of the actions set forth in <u>Section 3.1</u> of this Assignment and any or all other actions designated by Lender for the proper management and preservation of the Property.
- (j) Other Rights and Agreements. Any and all other rights of Grantor in and to the items set forth in subsections (a) through (i) above, and all amendments, modifications, replacements, renewals and substitutions thereof.
- Section 1.2 <u>CONSIDERATION</u>. This Assignment is made in consideration of that certain loan, made by Lender to Borrower evidenced by the Note and secured by that certain Mortgage and Assignment of Leases and Rents given by Grantor to or for the benefit of Lender, dated on even date hereof, in the principal sum of NINE HUNDRED FORTY TWO THOUSAND TWO HUNDRED AND NO/100 DOLLARS (\$942,200.00) covering the Property and intended to be duly recorded (the "Security Instrument"). The principal sum, interest and all

other sums due and payable under the Note, the Security Instrument, this Assignment and the Other Security Documents (defined below) are collectively referred to as the "Debt". The documents other than this Assignment, the Note or the Security Instrument now or hereafter executed by Grantor, Borrower and/or others and by or in favor of Lender which wholly or partially secure payment of the Debt are referred to herein as the "Other Security Documents".

Section 1.3 <u>TERMINATION OF ASSIGNMENT</u>. Upon payment in full of the Debt and the delivery and recording of a satisfaction or discharge of the Security Instrument duly executed by Lender, this Assignment shall become null and void and shall be of no further force and effect.

ARTICLE 2 – TERMS OF ASSIGNMENT

Section 2.1 PRESENT ASSIGNMENT AND LICENSE BACK. It is intended by Grantor that this Assignment constitute a present, absolute assignment of the Leases, Rents, Lease Guaranties and Bankrup cy Claims, and not an assignment for additional security only. Nevertheless, subject to the torus of this Section 2.1, Lender grants to Grantor a revocable license to collect and receive the Rents and other sums due under the Leases and Lease Guaranties. Grantor shall hold the Rents and a 1 sums received pursuant to any Leases or Lease Guaranties, or a portion thereof sufficient to discharge all current sums due on the Debt, in trust for the benefit of Lender for use in the payment of such sums.

Section 2.2 <u>NOTICE TO LESSEES</u> Grantor hereby agrees to authorize and direct the lessees named in the Leases or any other or future lessees or occupants of the Property and all Lease Guarantors to pay over to Lender or to such other party as Lender directs all Rents and all sums due under any Leases and Lease Guaranties upon receipt from Lender of written notice to the effect that Lender is then the holder of the Security Instrument and that a Default (defined below) exists, and to continue so to do until otherwise notified by Lender.

Section 2.3 <u>INCORPORATION BY REFERENCE</u>. All representations, warranties, covenants, conditions and agreements contained in the Security Instrument as same may be modified, renewed, substituted or extended are hereby made a part of this Assignment to the same extent and with the same force as if fully set forth herein.

ARTICLE 3 – REMEDIES

Section 3.1 <u>REMEDIES OF LENDER</u>. Upon or at any time after the occurrence of a default under this Assignment or an Event of Default by Grantor or Borrower (as defined in the Security Instrument) (a "<u>Default</u>"), the license granted to Grantor in <u>Section 2.1</u> of this Assignment shall automatically be revoked, and Lender shall immediately be entitled to possession of all Rents and sums due under any Leases and Lease Guaranties, whether or not Lender enters upon or takes control of the Property. In addition, Lender may, at its option, without waiving such Default, without notice and without regard to the adequacy of the security for the Debt, either in person or by agent, nominee or attorney, with or without bringing any action or proceeding, or by a receiver appointed by a court, dispossess Grantor and its agents and servants from the Property, without liability for trespass, damages or otherwise and exclude Grantor and its agents or servants wholly

therefrom, and take possession of the Property and all books, records and accounts relating thereto and have, hold, manage, lease and operate the Property on such terms and for such period of time as Lender-may deem proper and either with or without taking possession of the Property in its own name, demand, sue for or otherwise collect and receive all Rents and sums due under all Leases and Lease Guaranties, including those past due and unpaid with full power to make from time to time all alterations, renovations, repairs or replacements thereto or thereof as may seem proper to Lender and may apply the Rents and sums received-pursuant to any Leases and Lease Guaranties to the payment of the following in such order and proportion as Lender in its sole discretion may determine, any law, custom or use to the contrary notwithstanding: (a) all expenses of managing and securing the Property, including, without being limited thereto, the salaries, fees and wages of a managing gent and such other employees or agents as Lender may deem necessary or desirable and all expenses of operating and maintaining the Property, including, without being limited thereto, all taxe. charges, claims, assessments, water charges, sewer rents and any other liens, and premiums for all insurance which Lender may deem necessary or desirable, and the cost of all alterations, renovations, repairs or replacements, and all expenses incident to taking and retaining possession of the Property and (b) the Debt, together with all costs and reasonable attorneys' fees. In addition, upon the occurrence of a Default, Lender, at its option, may (1) complete any construction on the Property in such manner and form as Lender deems advisable, (2) exercise all rights and powers of Grantor, including, without limitation, the right to negotiate, execute, cancel, enforce or modify Leases, obtain and exict tenants, and demand, sue for, collect and receive all Rents from the Property and all sums due under any Lease Guaranties, (3) either require Grantor to pay monthly in advance to Lender, or any receiver appointed to collect the Rents, the fair and reasonable rental value for the use and occupancy of such part of the Property as may be in possession of Grantor or (4) require Grantor to vacue and surrender possession of the Property to Lender or to such receiver and, in default thereof, Granton may be evicted by summary proceedings or otherwise.

OTHER REMEDIES. Nething contained in this Assignment and no act Section 3.2 done or omitted by Lender pursuant to the power and rights granted to Lender hereunder shall be deemed to be a waiver by Lender of its rights and remedies under the Nove, the Security Instrument, or the Other Security Documents and this Assignment is made and accepted without prejudice to any of the rights and remedies possessed by Lender under the terms thereof. The right of Lender to collect the Debt and to enforce any other security therefor held by it may be exercised by Lender either prior to, simultaneously with, or subsequent to any action taken by it herevider. Grantor and Grantor hereby absolutely, unconditionally and irrevocably waives any and all rights to assert any setoff, counterclaim or cross-claim of any nature whatsoever with respect to the obligations of Grantor or Borrower under this Assignment, the Note, the Security Instrument, the Other Security Documents or otherwise with respect to the loan secured hereby in any action or proceeding brought by Lender to collect same, or any portion thereof, or to enforce and realize upon the lien and security interest created by this Assignment, the Note, the Security Instrument, or any of the Other Security Documents (provided, however, that the foregoing shall not be deemed a waiver of Grantor's right to assert any compulsory counterclaim if such counterclaim is compelled under local law or rule of procedure, nor shall the foregoing be deemed a waiver of Grantor's right to assert any claim which would constitute a defense, setoff, counterclaim or cross-claim of any nature whatsoever against Lender in any separate action or proceeding).

Section 3.3 <u>OTHER SECURITY</u>. Lender may take or release other security for the payment of the Debt, may release any party primarily or secondarily liable therefor and may apply any other security held by it to the reduction or satisfaction of the Debt without prejudice to any of its rights under this Assignment.

NON-WAIVER. The exercise by Lender of the remedies granted it in Section 3.4 Section 3.1 of this Assignment and the collection of the Rents and sums due under the Leases and Lease Guaranties and the application thereof as herein provided shall not be considered a waiver of any default by Grantor or Borrower under the Note, the Security Instrument, the Leases, this Assignment or the Other Security Documents. The failure of Lender to insist upon strict performance of any term hereof shall not be deemed to be a waiver of any term of this Assignment. Borrower or Grantor shall not be relieved of their obligations hereunder by reason of (a) the failure of Lender to courly with any request of Borrower or Grantor or any other party to take any action to enforce any of the provisions hereof or of the Security Instrument, the Note or the Other Security Documents, (b) the release regardless of consideration, of the whole or any part of the Property, or (c) any agreement or stipulation by Lender extending the time of payment or otherwise modifying or supplementing the terms of this Assignment, the Note, the Security Instrument or the Other Security Documents. Leader may resort for the payment of the Debt to any other security held by Lender in such order and manner as Lender, in its discretion, may elect. Lender may take any action to recover the Debt, or any nortion thereof, or to enforce any covenant hereof without prejudice to the right of Lender thereafter of enforce its rights under this Assignment. The rights of Lender under this Assignment shall be separate, distinct and cumulative and none shall be given effect to the exclusion of the others. No act of Lender shall be construed as an election to proceed under any one provision herein to the exclusion of any other provision.

- Section 3.5 <u>BANKRUPTCY</u>. (a) Upon or at any time after the occurrence of a Default, Lender shall have the right to proceed in its own name of in the name of Grantor in respect of any claim, suit, action or proceeding relating to the rejection of any Lease, including, without limitation, the right to file and prosecute, to the exclusion of Grantor, any proofs of claim, complaints, motions, applications, notices and other documents, in any case in respect of the lessee under such Lease under the Bankruptcy Code.
- (b) If there shall be filed by or against Grantor a petition under the Binkruptcy Code, and Grantor, as lessor under any Lease, shall determine to reject such Lease pursuant to Section 365(a) of the Bankruptcy Code, then Grantor shall give Lender not less than ten (19) days' prior notice of the date on which Grantor shall apply to the bankruptcy court for authority to reject the Lease. Lender shall have the right, but not the obligation, to serve upon Grantor within such tenday period a notice stating that (i) Lender demands that Grantor assume and assign the Lease to Lender pursuant to Section 365 of the Bankruptcy Code and (ii) Lender covenants to cure or provide adequate assurance of future performance under the Lease. If Lender serves upon Grantor the notice described in the preceding sentence, Grantor shall not seek to reject the Lease and shall comply with the demand provided for in clause (i) of the preceding sentence within thirty (30) days after the notice shall have been given, subject to the performance by Lender of the covenant provided for in clause (ii) of the preceding sentence.

ARTICLE 4 - NO LIABILITY, FURTHER ASSURANCES

NO LIABILITY OF LENDER. This Assignment shall not be construed to Section 4.1 bind Lender to the performance of any of the covenants, conditions or provisions contained in any Lease or Lease Guaranty or otherwise impose any obligation upon Lender. Lender shall not be liable for any loss sustained by Grantor resulting from Lender's failure to let the Property after a Default or from any other act or omission of Lender in managing the Property after a Default unless such loss is caused by the willful misconduct and bad faith of Lender. Lender shall not be obligated to perform or discharge any obligation, duty or liability under the Leases or any Lease Guaranties or under or by reason of this Assignment and Grantor shall, and hereby agrees, to indemnify Lencer for, and to hold Lender harmless from, any and all liability, loss or damage which may or might be incurred under the Leases, any Lease Guaranties or under or by reason of this Assignment and from any and all claims and demands whatsoever, including the defense of any such claims or demands which may be asserted against Lender by reason of any alleged obligations and undertakings on its part to perform or discharge any of the terms, covenants or agreements contained in the Leases or any Lease Guaranties. Should Lender incur any such liability, the amount thereof, including costs, expenses and reasonable attorneys' fees, shall be secured by this Assignment and by the Security Instrument and the Other Security Documents and Grantor shall reimburse Lender therefor musediately upon demand and upon the failure of Grantor so to do Lender may, at its option, declare all sums secured by this Assignment and by the Security Instrument and the Other Security Documents immediately due and payable. This Assignment shall not operate to place any obligation or liability for the control, care, management or repair of the Property upon Lender, nor for the carrying out of any of the terms and conditions of the Leases or any Lease Guaranties; nor shall it operate to make Lender responsible or liable for any waste committed on the Property by the tenants or any other parties or for any dangerous or defective condition of the Property, including without limitation the presence of any Hazardous Substances (as defined in the Security Instrument), or for any negligence in the management, upkeep, repair or control of the Property resulting in loss or injury or death to any terant, licensee, employee or stranger.

Section 4.2 <u>NO MORTGAGEE IN POSSESSION</u>. Grantor will, at the cost of Grantor, and without expense to Lender, do, execute, acknowledge and deliver all and every such further acts, conveyances, assignments, notices of assignments, transfers and assurances as Lender shall, from time to time, require for the better assuring, conveying, assigning, transferring and confirming unto Lender the property and rights hereby assigned or intended now or hereafter so to be, or which Grantor may be or may hereafter become bound to convey or assign to Lender, or for carrying out the intention or facilitating the performance of the terms of this Assignment or for filing, registering or recording this Assignment and, on demand, will execute and deliver and hereby

- <u>CERTAIN DEFINITIONS</u>. Unless the context clearly indicates a contrary Section 5.3 intent or unless otherwise specifically provided herein, words used in this Assignment may be used interchangeably in singular or plu al form and the word "Borrower" shall mean "each Borrower and any subsequent Borrower under the Note, the word "Grantor" shall mean "each Grantor and any subsequent Grantor or subsequent owner or owners of the Property or any part thereof or interest therein," the word "Lender" shall nlear "Lender and any subsequent holder of the Note," the word "Note" shall mean "the Note and any other evidence of indebtedness secured by the Security Instrument," the word "person" shall include an individual, corporation, partnership, limited liability company, trust, unincorporated association, government, governmental authority, and any other entity, the word "Property" shall include any portion of the Property and any interest therein, the phrases "attorneys' fees" and "counsel fees" shall include any and all attorneys', paralegal and law clerk fees and disbursements, including, but not limited to, fees and disbursements at the pre-trial, trial and appellate levels incurred or paid by Lender in protecting its interest in the Property, the Leases and the Rents and enforcing its rights hereunder, and the word "Debt" shall mean the principal balance of the Note with interest thereon as provided in the Note and the Security Instrument and all other sums due pursuant to the Note, the Security Instrument, this Assignment and the Other Security Documents; whenever the context viv require, any pronouns used herein shall include the corresponding masculine, feminine or neuter forms, and the singular form of nouns and pronouns shall include the plural and vice versa.

- Section 5.5 <u>INAPPLICABLE PROVISIONS</u>. If any term, covenant or condition of this Assignment is held to be invalid, illegal or unenforceable in any respect, this Assignment shall be construed without such provision.

GRANTOR HEREBY WAIVES, TO THE FULLEST EXTENT PERMITTED BY LAW, THE RIGHT TO TRIAL BY JURY IN ANY ACTION, PROCEEDING OR COUNTERCLAIM, WHETHER IN CONTRACT, TORT OR OTHERWISE, RELATING DERECTLY OR INDIRECTLY TO THE LOAN EVIDENCED BY THE NOTE, THE APPLICATION FOR THE LOAN EVIDENCED BY THE NOTE, THIS ASSIGNMENT, THE NOTE, THE SECURITY INSTRUMENT OR THE OTHER SECURITY DOCUMENTS OR ANY ACTS OR OMISSIONS OF LENDER, ITS OFFICERS, EMPLOYEES, DIRECTORS OR AGENTS IN CONNECTION THEREWITH.
- Section 5.10 <u>LIABILITY</u>. If Grantor consists of more than one person, the obligations and liabilities of each such person hereunder shall be joint and several. This Assignment shall be binding upon and inure to the benefit of Grantor and Lender and their respective successors and assigns forever.
- Section 5.11 <u>HEADINGS, ETC</u>. The headings and captions of various paragraphs of this Assignment are for convenience of reference only and are not to be construed as defining or limiting, in any way, the scope or intent of the provisions hereof.
- Section 5.12 <u>NUMBER AND GENDER</u>. Whenever the context may require, any pronouns used herein shall include the corresponding masculine, feminine or neutral forms, and the singular form of nouns and pronouns shall include the plural and vice versa.
- Section 5.13 <u>SOLE DISCRETION OF LENDER</u>. Wherever pursuant to this Assignment (a) Lender exercises any right given to it to approve or disapprove, (b) any arrangement or term is to be satisfactory to Lender, or (c) any other decision or determination is to be made by Lender, the decision of Lender to approve or disapprove, all decisions that arrangements or terms are satisfactory or not satisfactory and all other decisions and determinations made by Lender, shall be in the sole discretion of Lender, except as may be otherwise expressly and specifically provided herein.
