Items at any time. Any such waiver may only be in writing. In the event of such waiver, Borrower shall pay directly, when and where payable, the amounts due for any Escrow Items for which payment of Funds has been waived by Lender and, if Lender requires, shall furnish to Lender receipts evidencing such payment within such time period as Lender may require. Lender may require Borrower to pay a one-time charge for a real estate tax verification and/or reporting service used by Lender in connection with this Loan.

**5. Property Insurance.** Borrower shall keep the improvements now existing or hereafter erected on the Property insured against loss by fire, hazards included within the term "extended coverage," and any other hazards including, but not limited to, earthquakes and floods, for which Lender requires insurance. to Lender (a) Borrower's rights to any insurance proceeds in an amount not to exceed the amounts unpaid under the Note or this Security Instrument, and (b) any other of Borrower's rights (other than the right to any refund of unearned premiums paid by Borrower) under all insurance policies covering the Property, insofar as such rights are applicable to the coverage of the Property. Beginning at the intersection of the South line of the above described North 20 rods with a line drawn midway between the East line of Clifton Avenue and the West line of Cumberland Avenue; thence East along the South line of the above described North 20 rods for a distance of 9.99 feet, more or less, to an intersection with a line drawn parallel with and 177 feet (measured at right angles) West of the West line of Cumberland Avenue; thence North along the last described parallel line for a distance of 57.52 feet, more or less, to an intersection with a line drawn at right angles to the West line of Cumberland Avenue at a point vinicity is 50 feet (measured along the West line of Cumberland Avenue with the South line of the above 20 rods; thence West along said line drawn at right angles to the Viest line of Cumberland Avenue for a distance of 9.98 feet, more or less to an intersection with the line drawn midway poliween the East line of Clifton Avenue and the West line of Cumberland Avenue; thence South for a distance of \$7.95 feet, more or less, to the point of beginning.
