SUBJECT TO: Easements of record and real estate taxes for 1972 and subsequent years.

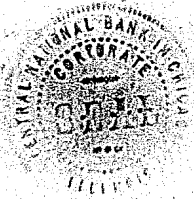

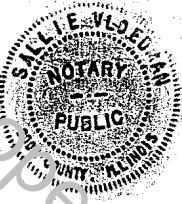
