MEMORANDUM OF ASSIGNMENT AND ASSUMPTION OF LEASE

THIS MEMORANDUM AND ASSIGNMENT OF LEASE (this "Memorandum") is made and entered into effective as of October 19, 2022 (the "Effective Date"), by and among MGH HILLSIDE LLC, an Illinois limited hability company ("Lessor"), AMERIGAS PROPANE, L.P., a Delaware limited partnership ("Lessee"), and MONOMOY PROPERTIES HILLSIDE IL, LLC, a Delaware limited liability company ("Assignee"). Lessee and Assignee agree to and acknowledge the following matters:

- Leased Premises. Lessor and Lessee entered into that certain Lease Agreement dated as of September 28, 2018, as amended by that certain Amended and Restated Lease Agreement dated as of August 19, 2022 and effective as of October 1, 2023 (collectively, the "Lease"), pursuant to which Lessor leased to Lessee, and Lessee leased from Lessor, subject to the terms, covenants and conditions contained therein, the leased premises located at 4158 D vision Street, Hillside, Cook County, Illinois 60162 (the "Leased Premises"), and legally described on Extibit A attached hereto and incorporated herein by this reference. Lessor is the owner of the Leased Premises.
- 2. Term. The term of the Lease commenced on October 1, 2018 and will expire on September 30, 2026.
- 3. Assignment. Lessee and Assignee entered into that certain Assignment and Assumption of Lease dated as of the Effective Date (the "Assignment"), pursuant to which Lessee sold, assigned and transferred all of Lessee's right, title and interest in, under and to the Lease and Assignee accepted the foregoing assignment and assumed Lessee's duties and obligations under the Lease arising after the Effective Date.
- 4. <u>Ratification of Lease</u>. Lessor expressly ratifies, adopts, approves, confirms and declares the Lease to be a binding and enforceable obligation of Lessor.
- 5. <u>Successors and Assigns</u>. The conditions and provisions hereof shall inure to the benefit of and shall be binding upon Lessor, Lessee, Assignee and their respective personal representatives, successors and assigns and shall run with the land.
- 6. Recording. This Memorandum shall be recorded in Cook County, Illinois, in lieu of recording the Lease.
- 7. <u>Counterparts</u>. This Memorandum may be signed in counterparts, each of which shall be deemed an original and all of which when taken together shall constitute one instrument.
- 8. <u>No Alteration of Lease</u>. This Memorandum does not alter the terms and conditions of the Lease.
