UNIT 6-J as delineated on survey of the following parcel of real estate (hereinafter referred to as "Parcel"):

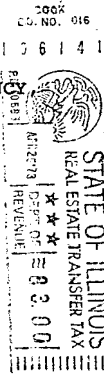

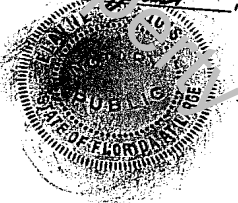
