Unit 6/2 as delineated on survey of the following described parcel of real estate (hereinafter referred to as "Parcel"): Lot 3 and that part of Lot 2 in River Oaks West Init 1, being a Subdivision of part of the Northwest Quarter of Section 24 and 'or part of Lot 1 lying North of the Little Calumet River in the Subdivision of the Southwest Quarter of Section 24, Township 36 North, Range 14, East of the Third P inc pal Meridian lying above a horizontal plane drawn at an elevation of 609.13 (U.s.G.S.
