WITNESSETH, that said party of the first part, in consideration of the sum of Ten and no/100 Dollars, (\$ 10.00) and other good and valuable considerations in hand paid, does hereby grant, sell and convey unto said party of the second part, the following described real estate, situated in COOK County, Illinois, to wit:

Unit No. 20-D delineated on the survey of the following described parcel of real estate (hereinafter referred to as "Parcel"):

That part of Block 2 in Valley Lo-Unit Five, being a Subdivision in Section 23, Township 42 North, Range 12 East of the Third Principal Meridian, in Cook County, Illinois, described as follows: Commencing on the north line of said Block 2, at a point which is 151.93 feet east from the northwest corner of said Block 2, and running thence south along a line perpendicular to said north line of Block 2, a distance of 132.50 feet to a point of beginning at the northwest corner of said part of Block 2 hereinafter described; thence continuing south along said perpendicular line, a distance of 184.44 feet to a point on the northeasterly line of Wildberry Drive; thence east along a straight line, a distance of 135.84 feet to a point which is 316.94 feet south from the north line of said Block 2; thence north along a line which is perpendicular to said north line of Block 2, (and which intersects said north line of Block 2 at a point 1652.77 feet east from the northwest corner of said Block 2), a distance of 184.44 feet; and thence west along a line 132.50 feet south from and parallel with said north line of Block 2, a distance of 135.84 feet to the point of beginning.
