Maintenance of Insurance. Grantor shall procure and maintain policies of fire insurance with standard extended coverage endorsements on a replacement basis for the full insural le value covering all Improvements on the Real Property in an amount sufficient to avoid application of any concourance clause, and with a standard mortgagee clause in favor of Lender. Grantor shall also procurs and maintain comprehensive general liability insurance in such coverage amounts as Lender may request with Lender being named as additional insureds in such liability insurance policies. Policies shall be written by such insurance companies and in such form as may be reasonably acceptable to Lender.
