"Unless the holder of the Certificate for Real Estate purchased at any Tax Sale under this act fails to file a Deed as entitled by law, and files the same for record within one year from and after the date for redemption expires, the said Certificate or Deed, and the sale on which it is based, shall from and after the expiration of such one year, be absolutely null. If the holder of the Certificate shall be prevented from obtaining such Deed by injunction or order of the Court, or by refusal of the Clerk to execute the same, the time he is so prevented shall be excluded from the computation of such time."
