Interest Rate is hereby increased from a Fixed Rate of 5.000% to 5.750%. Extend Maturity Date from September 29, 2022 to March 29, 2023. All other terms and conditions of the original promissory note and any/all renewals, extensions, modifications, change in terms agreements or amendments to note, remain unchanged and in full force and effect.

CONTINUING VALIDITY. Except as expressly modified above, the terms of the original Mortgage shall remain unchanged and in full force and effect and are legally valid, binding, and encoreable in accordance with their respective terms. Consent by Lender to this Modification does not waive Lender's right to require strict performance of the Mortgage as changed above nor obligate Lender to make any juture modifications.
