SUBORDINATION AGREEMENT

This agreement is made this April 20, 2022 by and between The Huntington National Bank, a national banking association (Subordinating Party), and The Huntington National Bank ISAO/VATIMA, (New Lender). WITNESSETH, that WHEREAS, Subordinating Party is the holder of a mortgage recorded on December 12, 2006 in Instrument No. 0634608207 (the Subordinated Mortgage) covering the following described premises:

WHEREAS, New Lender will be the holder of a certain proposed mortgage (the New Mortgage) for an amount not to exceed \$319,000.00. NOW, THEREFORE, in consideration of the proposed mortgage loan to be made to Ireneo C. Mandin and Maria G. Mandin, husband and wife, tenants by the entirety by New Lender, as herein set forth, the Subordinating Party hereby covenants and agrees with New Lender that the Subordinated Mortgage in the amount of \$20,000.00, permanently reduced to \$5,814.00, will be and shall continue to be subject and subordinate in lien to the New Mortgage and interest thereon, and to all advances to be made thereon, including all sums advanced for the purpose of paying fees, brokerage, and other expenses incident to the obtaining or making of the New Mortgage, in an amount not to exceed \$319,000.00.

This agreement shall be binding upon and inure to the benefit of the parties to this agreement, their respective heirs, personal representatives, successors, and assigns.
