2. Application of Payments. Unless applicable law provides otherwise, all payments received by us under the Agreement and Section 1 shall be applied by us as provided in the Agreement.

3. Prior Mortgages; Charges; Liens. You have disclosed to us and obtained our approval of any mortgage, deed of trust or other security agreement with a lien which has priority over this Mortgage. You shall perform all of your obligations under any mortgage, deed of trust or other security instruments with a lien which has priority over this Mortgage, including your covenants to make payments when due. - 14. Transfer of the Property. If all or any part cashes coned any interest in it is sold or transferred without our prior written consent, we may, at our option, require interesting payment in full of all sums secured by this Mortgage. However, this option shall not be exercised by us if countries is prohibited by federal law as of the date of this Mortgage.
- 15. Sale of Agreement; Change of Loan Services The Agreement or a partial interest in the Agreement (together with this Mortgage) may be sold one or more times without prior notice to you. A sale may result in a change in the entity (known as the "Loan Servicer") that collects monthly payments due under the Agreement and this Mortgage. There also may be one or more changes of the Loan Servicer arrelated to the sale of the Agreement. As used in this Mortgage, "Environmental Law" maans federal laws and laws of the jurisdiction where the Property is located that relate to health, safety or environmental protection.
- 17. Acceleration; Remedies. You will be in default if (1) any payment required by the Agreement or this Mortgage is not made when it is due; (2) we discover that you have committed fraud or made a material misrepresentation in connection with the Agreement; or (3) your action, or your failure to act, adversely affects our security for the Agreement or any right we have in the Property.
