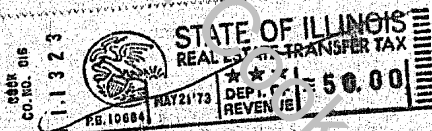
TRUSTEE'S DEED

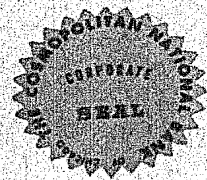
