WHEREAS, MARGARET G. MEYER, Deceased, resided in the County of Cook and State of Illinois, and died leaving a Will, and thereafter proceedings were instituted in the Circuit Court of Cook County, Illinois to probate the estate of said Deceased; and on May 3, 1972 Grantor was duly appointed and qualified as Administrator With The Will Annexed of said estate, and Letters of Administration issued out of said Court to Grantor, and said letters are now in full force and effect; and

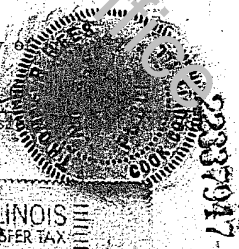
