TRUST DEED AND NOTE

THIS INDENTURE WITNESSETH, That the undersigned as grantor, of GLENVIEW, County of COOK,
and State of ILLINOIS, for and in consideration of the sum of One Dollar and other good and valuable considerations, in hand paid,
convey and warrant to JEROME R. THOMAS of 33 N. LASALLE STREET,
County of COOK and State of ILLINOIS, the following described Real Estate, with all improvements
thereon, situated in the County of COOK, in the State of ILLINOIS, to wit:
LOT 106 in Arthur T. McIntosh Co's Glenview Country side Subdivision in Section
33 Township 42 North, Range 12 EAST OF THE THIRD PRINCIPAL MERIDIAN.

hereby releasing and waiving all rights under and by virtue of the homestead exemption laws of the State of ILLINOIS.

GRANTORS AGREE to pay all taxes and assessments upon said property and to keep the buildings thereon insured to their full insurance value, to remove prior incumbrances and the like, and to keep the property tenable and in good repair and free of liens. In the event of failure of Grantors to comply with any of the above covenants, then grantee is authorized to attend to the same and pay the bills therefor, which shall be held in trust for him, to become due immediately, without demand. On default in any payments hereunder, grantee may declare the whole debt due and proceed accordingly.

AS FURTHER SECUR., Grantor hereby assign, transfer and set over to grantee all the rents, issues and profits of said premises, from and after the date hereof, to him to sue for, collect and receipt for the same, to serve all necessary notices and demands, to bring forcible distress proceedings to recover possession thereof, to rent the said premises as he may deem proper and to apply the money so arising to the payment of this indebtedness, or to any expenses made as aforesaid, and it shall not be the duty of grantee to inquire into the validity of any such taxes, assessments, liens, encumbrances, interest or advancements.

In trust, nevertheless, for the purpose of securing performance of the following obligation, to wit:

at the option of the legal holder of this instrument with interest at 6 per cent. per annum after date hereof until paid.

And to secure the payment of said amount I (we) do, by authority, irrevocably any attorney of any court or record in any County or State in the United States to appear for us in such court, in term, quo or vacation, at any time hereafter and confess a judgment without process in favor of the holder of this instrument for such amount as may appear to be unpaid thereon, together with costs, and Twenty-Five Dollars Attorney's fees, and to waive and release all errors which may intervene in any such proceedings, and consent to immediate execution upon such judgment, hereby ratifying and confirming all that my (our) said attorney may do by virtue hereof.

IN THE EVENT of the death, inability, removal or absence of the COOK County of the Trustee, or of his refusal or failure to act, then CHICAGO TITLE & TRUST CO., CHICAGO, of said County, is hereby appointed to be the first successor to this trust; and if for any like cause first successor fail or refuse to act, the person who shall then be the acting Recorder of Deeds of said County is hereby appointed to be second successor to this trust. And we, all the aforesaid covenants and agreements are performed by trustee, or his successor in trust, shall release the premises to the party entitled to them in receiving his reasonable charges.
