Lot 1 in the Resubdivision of Lot 9 in Block 16 in Midlothian Gardens being a Subdivision of that part of the South East quarter of Section 10, Township 36 North, Range 13, East of the Third Principal Meridian lying West of the Right of Way of the Chicago, Rock Island and Pacific Railroad; also the East 47/160 of the South West quarter of Section 10, aforesaid, in Cook County, Illinois.

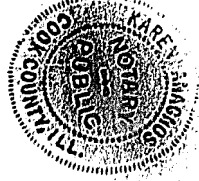
