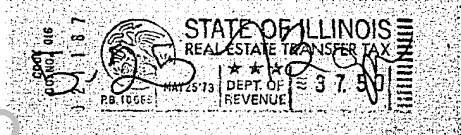

GRANTEE RESIDES AT 43 E. 163rd Street, South Holland, Illinois

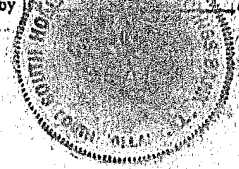
