Such loss reserve shall be non-refundable, notwithstanding the fact that the Loan is ultimately paid in full, and Lerder shall not be required to pay Borrower any interest or earnings on such loss reserve. 13. Joint and Several Liability; Co-signers; Successors and Assigns Bound. Borrower covenants and agrees that Borrower's obligations and liability shall be joint and several. 



D. RENT LOSS INSURANCE. Borrower shall maintain insurance against rent loss in addition to the other hazards for which insurance is required by Section 5.
