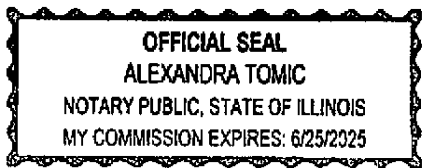

EXHIBIT "B" PERMITTED EXCEPTIONS
