CONVEY and WARRANT to HACKNEY'S ON LAKE, INC.

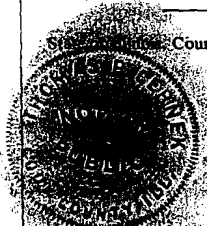
