

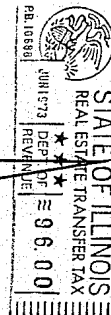

The East 110 feet of the West 314 feet of the South 100 feet of the North 307 feet of that part of the North West 1/4 of Section 31, Township 36 North, Range 13, East of the Third Principal Meridian, lying North of the Right of Way of the Chicago, Rock Island and Pacific Railroad, in Cook County, Illinois.



together with the tenements and appurtenances thereunto belonging.

To Have and to Hold These premises unto said parties of the second part forever, not in tenancy in common, but in joint tenancy.

Subject to: The real estate taxes for the year 1971 and for all subsequent years.
 Covenants, conditions, restrictions and easements of record.



This deed is executed pursuant to and in the exercise of the power and authority granted to and vested in said trustee by the terms of said deed or deeds in trust delivered to said trustee in pursuance of the trust agreement above mentioned. This deed is made subject to the lien of every trust deed or mortgage (if any there be) of record in said county given to secure the payment of money and remaining unreleased at the date of the delivery hereof.
