## LEGAL DESCRIPTION RIDER

Unit No. 3-G as delineated on Plat of Survey of the following described parcel of real estate (hereinafter referred to as "Parcel"): Lots 1, 2, 3 and 4 in Block 8 in Angelina Dymiewicz Park Subdivision of the North East Quarter of of the South West Quarter of Section 8, Township 40 North, Range 13 East of the Third Principal Meridian in Cook county, Illinois, which Plat of Survey is attached as Exhibit A to Declaration of Condominium made by Chicago Title and Trust Company, a corporation, as Trustees under Trust Agreement dated May 31, 1972 and known as Trust 60012, and recorded in the office of Recorder of Deeds of Cook County, Illinois as Document 22281103, together with an undivided 2.900 per cent interest in said parcel (excepting from said parcel all the property and space comprising all the units thereof as defined and set forth in said Declaration and Plat of Survey).

Grantor also hereby grants to Grantees, their heirs, assigns, and assigns, as rights and easements appurtenant to the above described real estate, the rights and easements for the benefit of the property set forth in the aforementioned Declaration and Grantor reserves to itself, its successors and assigns the rights and easements set forth in said Declaration for the benefit of the remaining property described therein.

This Deed is subject to all rights, easements, restrictions, conditions, covenants and reservations contained in the said Declaration the same as though the provisions of said Declaration were recited and stipulated at length herein.
