Unit No. 1-I, as delineated on Plat of Survey of the following described parcel of real estate (hereinafter referred to as "Parcel"): Lots 1, 2, 3 and 4 in Block 8 in Angeline Dyniewicz Park Subdivision of the North East Quarter of the South West Quarter of Section 8, Township 40 North, Range 13 East of the Third Principal Meridian in Cook county, Illinois, which Plat of Survey is attached as Exhibit A to Declaration of Condominium made by Chicago Title and Trust Company, a corporation, as Trustee under Trust Agreement dated May 31, 1972 and known as Trust 60012, and recorded in the office of Recorder of Deeds of Cook County, Illinois as Document 22281103, together with an undivided 3.413 per cent interest in said parcel (excepting from said parcel all the property and space comprising all the units thereof as defined and set forth in said Declaration and Plat of Survey).
