The Grantors release and waive all rights in said real estate under and by virtue of the homestead exemption laws of the State of Illinois.

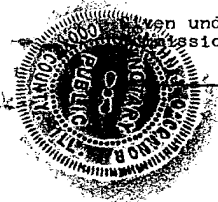
