Hillstrom and Edith L. Hillstrom, his wife, parties of the second part. WITNESSETH that said party of the first part, in consideration of the sum of Ten and no/100 (\$10.00) --- dollars, and other good and valuable considerations in hand paid, does hereby grant, sell and convey unto said parties of the second part, not as tenants in common, but as joint tenants, the following described real estate, situated in Cook County, Illinois, to-wit:

That part of Block 2 in Valley Lo-Unit Five, being a Subdivision in Section 23, Township 42 North, Range 2 East of the Third Principal Meridian, in Cook County, Illinois, described as follows: Beginning on the north line of said Block 2, at a point which is 1413.87 feet east from the northwest corner of said Block 2, and running thence south along a line perpendicular to said north line of Block 2, a distance of 310.0 feet to the north line of Wildberry Drive; thence east along said north line of Wildberry Drive, being here a straight line, a distance of 70.47 feet to a point of curve; thence southeastwardly along the northeasterly line of Wildberry Drive, being here the arc of a circle convex to the northeast and having a radius of 80 feet, a distance of 33.56 feet to an intersection with a line which is perpendicular to the north line of said Block 2, and which intersects the north line of said Block 2 at a point which is 1516.93 feet east from the northwest corner of said Block 2; thence north along said last described perpendicular line, a distance of 316.94 feet to said north line of Block 2, and thence west along said north line of Block 2, a distance of 103.06 feet to the point of beginning. together with an undivided 10.37% interest in said Parcel (excepting from said Parcel all property and space comprising all the Units thereon as defined and set forth in said Declaration of Condominium and survey).

Grantor furthermore expressly grants to the parties of the second part, their successors and assigns, as rights and easements appurtenant to the above-described real estate, the rights and easements for the benefit of said property set forth in the aforementioned Declaration, and the rights and easements set forth in other Declarations of Condominium Ownership whether heretofore or hereafter recorded affecting other premises in Block 2 in Valley Lo Unit Five Subdivision aforesaid, including, but not limited to, the easements for ingress and egress.

This conveyance is made subject to all rights, benefits, easements, restrictions, conditions, reservations and covenants contained in said Declaration, and the grantor expressly reserves to itself, its successors and assigns, the rights, benefits and easements set forth in said Declaration for the benefit of all remaining property described in said survey or said Declaration.
