

ASSOCIATE JUDGE'S DEED

WHEREAS, on the 8th day of January, 1969, in case number 67 D 21115 entitled JOYCE MOODY JONES, vs. BROWN JONES, JR., the plaintiff was granted a judgment for divorce from said BRWON JONES, JR. wherein said judgment for divorce provided that the defendant, BROWN JONES, JR. should execute and deliver to JOYCE MOODY JONES, plaintiff, a deed conveying all of his right, title and interest in the real estate hereinbelow described;

THAT on July 6, 1973 an Order of Court was entered pursuant to the Petition of JOYCE MOODY JONES a/k/a JOYCE MOODY MINOR which found that the defendant had failed to execute and deliver such a deed or to place any such deed on record and ordered that an Associate Judge's Deed issue to and for the benefit of the plaintiff, conveying to her all of the right, title and interest of the defendant in the real estate hereinbelow described;

THAT the said defendant, BROWN JONES, JR. having failed to execute any such deed as aforesaid;

NOW THEREFORE, know all men by these presents, that I, CARL F. FAUST, an Associate Judge of the Land Title Section of the Circuit Court of Cook County, Illinois, in consideration of the premises, do hereby convey to the said JOYCE MOODY MINOR of 636 East 92nd Place, Chicago, Illinois, her heirs and assigns forever, the following described premises to-wit:

"Lot Thirty-Two (32) in Block 1 of Subdivision (53) in S.E. Gross' Third Addition to Dauphin Park, being a subdivision of the South Half of the northeast quarter of the south 3/4 quarter of section three (3) Township Thirty-Seven (37) North, Range Fourteen (14), East of the Third Principal Meridian in Cook County Illinois."

TO have and hold the same, with all the appurtenances thereto belonging, to the said JOYCE MOODY MINOR, her heirs and assigns forever.

THIS deed is executed and delivered solely in compliance with the Order of Court supplementing the Decree for Divorce herein above referred to.

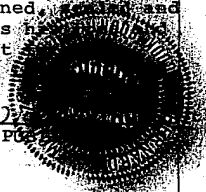
