THE FOLLOWING ARE THE COVENANTS, CONDITIONS AND PROVISIONS REFERRED TO ON PAGE 1 (THE REVERSE SIDE OF THIS TRUST DEED) AND WHICH FORM A PART OF THE TRUST DEED WHICH THERE BEGINS:

- 1. Mortgagors shall (1) keep said premises in good condition and repair, without waste: (2) promptly repair, reatore, or rebuild any buildings or improvements now or hereafter on the premises which may become damaged or be destroyed; (3) keep said premises free from mechanic's liens or liens in favor of the United States or other liens or claims for lien not expressly subordinated to the lien hereof; (4) pay when due any indebtedness which may be secured by a lien or charge on the premises superior to the lien hereof, and upon request exhibit satisfactory evidence of the diacharge of such prior lien to Trustee or to holders of the note; (5) complete within a reasonable time any buildings now or at any time in process of erection upon said premises. (6) comply with all requirements of law or municipal ordinances with respect to the premises and the use thereof, (7) make no-material alterations in said premises exactly as required by law or municipal ordinance or as previously consented to in writing by the Trustee or holders of the note.
- 2. Mortgagors shall pay before any penalty attaches all general taxes, and shall pay special taxes, special assessments, water charges, sewer service charges, and other charges against the premises when due, and shall, upon written request, furnish to Trustee or to holders of the note the original or duplicate receipts therefor. To prevent default hereunder Mortgagors shall pay in full under protest, in the manner provided by statute, any tax or assessment which Mortgagors may desire to contest.
- 3. Mortgagors shall keep all buildings and improvements now or hereafter situated on said premises insured against loss or damage by fire, lightning and windstorm under policies providing for payment by the insurance companies of moneys sufficient either to pay the cost of replacing or repairing the same or to pay in full the indehtedness secured hereby, all in companies satisfactory to the holders of the note, under insurance policies payable, in case of loss or damage, to Trustee for the benefit of the bolders of the note, such rights to be evidenced by the standard mortgage claus. To be attached to each policy, and shall deliver all policies, including additional and renewal policies, to holders of the note, and in case of its rar is about to expire, shall deliver renewal policies not less than ten days prior to the respective dates of expiration.
- 4. In case of default therein. Trustee or the holders of the note may, but need not, make any payment or perform any act hereinbefore required of Mr. (pp. rs. in any form and manner deemed expedient, and may, but need not, make full or partial payments of principal or interest on prior encumbra (ces. if any, and purchase, discharge, compromise or settle any tax lie no other prior lie no title or claim thereof, or redeem from any tax sile or fretures affecting said premises or context any tax or assessment. All moneys paid for any of the purposes herein authorized and all expenses paid of incurred in connection therewith, including reasonable attorneys fees, and any other moneys advanced by Trustee or the holders of the nor to rotect the mortizaged premises and the lien hereof, plus reasonable compensation to Trustee for each matter concerning which action herein authorized the nor to rotect the mortizaged premises and the lien hereof, plus reasonable compensation to Trustee for each matter concerning which action herein authorized the result of seven per cent per annum.
