Said parties of the first part further covenant and agree to deposit with the Trustee or the Legal Holder of the within mentioned note on the 1st day of each and every month, during the term of said loan, commending on the 1st day of August, 1976, a sum equal to one-twelfth (1/12th) of the estimated general real estate taxes next accruing against said premises computed on the amount of last ascertainable real estate taxes and one-twelfth (1/12th) of the annual insurance premiums, such sums to be held in a non-interest bearing account by the Trustee or the Legal Holder of the note as and for a Sinking Fund to be used by the Trustee or the Legal Holder of the Note, to pay the general real estate taxes levied against said premises and insurance premiums as and when the same become due and payable.

18. In the event of a Sale er Conveyance of the property described herein the entire balance remaining unpaid on this mortgage shall become due and payable immediately at option of the Holder of the Note.

19. The mortgagors hereby waive any and all rights of redemption from sale under any order or decree of foreelesure of this Trust Deed, and its sum behalf and on behalf of each and every person, except decree or judgment creditors of the mortgagor, acquiring any interest in or title to the premises subsequent to the date of this Trust Deed.
