QUIT CLAIM DEED 23 469 442

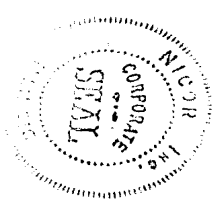

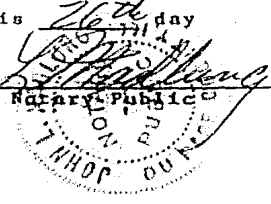

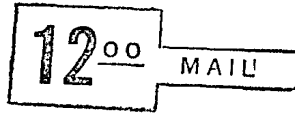
