

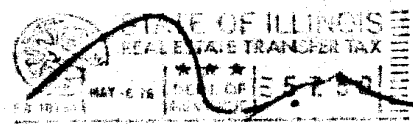

This Indenture, made this 19th day of April, 1976, between CENTRAL NATIONAL BANK IN CHICAGO, a corporation duly organized and existing as a national banking association under the laws of the United States of America, and duly authorized to accept and execute trusts within the State of Illinois, not personally but as Trustee under the provisions of a deed or deeds in trust duly recorded and delivered to said national banking association in pursuance of a certain Trust Agreement, dated the 14th day of June, 1974, and known as Trust Number 20657, party of the first part, and Paterno L. Evangelista and Gloria M. Evangelista, his wife of Cook County, Illinois, not as tenants in common, but as joint tenants, parties of the second part.

WITNESSETH, that said party of the first part, in consideration of the sum of \$10.00 Ten and 00/100 Dollars, and other good and valuable considerations in hand paid, does hereby grant, sell and convey unto said parties of the second part, not as tenants in common, but as joint tenants, the following described real estate, situated in Cook County Illinois, to-wit:

Lot 10 and the South 10 feet of Lot 9 in Block 7 in Harry A. Roth and Company's Broadview Heights, a Subdivision of that part of the North West quarter of Section 23, Township 41 North, Range 13 East of the Third Principal Meridian, lying Easterly of East Prairie Road, in Skokie, Cook County, Illinois

together with the tenements and appurtenances thereto belonging.

TO HAVE AND TO HOLD the above granted premises unto the said parties of the second part forever, not in tenancy in common, but in joint tenancy.

SUBJECT TO: Taxes for 1975 and after; all covenants, conditions and restrictions of record.
