## THE FOLLOWING ARE THE COVENANTS, CONDITIONS AND PROVISIONS REFERRED TO ON PAGE 1 (THE REVERSE SIDE OF THIS TRUST DEED) AND WHICH FORM A PART OF THE TRUST DEED WHICH THERE BEGINS:

- 1. Mortgagors shall (1) keep said premises in good condition and repair, without waste; (2) promptly repair, restore, or rebuild any buildings or improvements now or hereafter on the premises which may become damaged or be destroyed; (3) keep said premises free from mechanic's liens or liens in favor of the United States or other liens or claims for lien not expressly subordinated to the lien hereof; (4) pay when due any indebtedness which may be secured by a lien or charge on the premises superior to the lien hereof, and upon request exhibit satisfactory evidence of the discharge of such prior lien to Trustee or to holders of the note; (5) complete within a reasonable time any buildings now or at any time in process of erection upon said premises, (6) comply with all requirements of law or municipal ordinances with respect to the premises and the use thereof, (7) make no material alterations in said premises except as required by law or municipal ordinance or as previously consented to in writing by the Trustee or holders of the note.
- 2. Mortgagors shall pay before any penalty attaches all general taxes, and shall pay special taxes, special assessments, water charges, sewer service charges, and other charges against the premises when due, and shall, upon written request, furnish to Trustee or to holders of the note the original or duplicate receipts therefor. To prevent default hereunder Mortgagors shall pay in full under protest, in the manner provided by statute, any tax or assessment which Mortgagors may desire to contest.
- 3. Mortgagors shall keep all buildings and improvements now or hereafter situated on said premises insured against loss or damage by fire, lightning and windstorm under policies providing for payment by the insurance companies of moneys sufficient either to pay the cost of replacing or repairing the same or to pay in full the indebtedness secured hereby, all in companies satisfactory to the holders of the note, under insurance policies payable, in case of loss or damage, to Trustee for the benefit of the holders of the note, such rights to be evidenced by the standard mortgage clause to be attached to each policy, and shall deliver all policies, including additional and renewal policies, to holders of the note, and in case of insurance about to expire, shall deliver renewal policies not less than ten days prior to the respective dates of expiration.
- 4. In case of default therein, Trustee or the holders of the note may, but need not, make any payment or perform any act hereinbefore required of Mortig gors in any form and manner deemed expedient, and may, but need not, make full or partial payments of principal or interest on prior energing as exist, if any, and purchase, dischaige, compromise or settle any tax line or other prior lien or title or claim thereof, or redeem from any tax sale or for feiture affecting said premises or context any tax or assessment. All moneys paid for any of the purposes herein authorized and all expense paid or incurred in connection therewith, including reasonable attorneys fees, and any other moneys advanced by Trustee or the holders of the not to protect the mortgaged premises and the lien hereof, plus reasonable compensation to Trustee for each matter concerning which action here in a thorized may be taken, shall be so much additional indebtedness secured hereby and shall become immediately due and payable without noises and with interest thereon at the rate of seven per cent per annum. Inaction of Trustee or holders of the notes shall never be considered as a wiver of any right accruing to them on account of any default hereunder on the part of Mortgagors.
- 5. The Trustee or the so less of the note hereby secured making any payment hereby authorized relating to taxes or assessments, may do so according to any bill, securacy of such bill, statement or estimate or into the volution of any tax, assessment, sale, forfeiture, tax hen or title or claim thereof.
- 6. Mortgagors shall pay ea n it m of indebtedness berein mentioned, both principal and interest, when due according to the terms hereof. At the election of the holders of the principal note, and without notice to Mortgagors, all unpaid indebtedness secured by this Trust Deed shall, notwithstanding anything in the principal note or in this Trust Deed to the contrary, become due and payable when default shall occur in payment of principal or interest, or in case default van occur and continue for three days in the performance of any other agreement of the Mortgagors herein contained.
- 7. When the indebtedness hereby secure a shall become due whether by the terms of the note described on page one or by acceleration or otherwise, holders of the note or Trustee shall have fact, that to foreclose the lien hereof, there shall be all other rights provided by the laws of Illinois for the enforcement of a motifage debt, in any suit to foreclose the lien hereof, there shall be allowed and included as additional indebtedness in the decree for sale all expenditures at despenses which may be paid or incurred by or on behalf of Trustee or holders of the note for attorneys fees. Trustees's fees, appraisars's fees, outlay, on, summentars and expert evidence, stenographers' charges, publication costs and costs (which may be estimated as to items to be expended all the risk of the decree to forecuring all such abstracts of title, title searches and examinations, guarantee policies. The proceeds of any foreclosure sale of the premises shall be distribute and applied in the following order of priority: First, on account of all costs and expenses incident to the toreclosure proceedings, including all such items as are mentioned in the preceding paragraph hereof; second, all other items which under the terms hereof constitute secured indebtedness of all onal to that evidenced by the note hereby secured, with interest thereof as herein provided; third, all principal and interest remaining unpaid from h, any overplus to Mortgagors, their heirs, legal representatives or assigns as their rights may appear
- 9. Upon or at any time after the filing of a complaint to foreclose this Trust Deed, he fourt in which such complaint is filed may appoint a receiver of said premises. Such appointment may be made either before or after sale, without regard to the solvency or insolvency of Mortgagors at the time of application for such receiver and without regard to the then, aute of the remises or whether the same shall be then complete as a homestead or not and the Truste hereunder may be appointed as such receiver. Such receiver establl have power to collect the rents, issues and profits of said premises during the pendency of such foreclosure suit and, in case of a ale and a deficiency, during the full statutory period for redemption, whether there be redemption or not, as well as during any further times who Mor gagors, except for the intervention of such receiver, would be entitled to collect such tents, issues and profits, and all other powers which may be presented for the protection, possession, control, management and operation of the premises during the whole of said profits and in such cases for the protection, possession, control, management and operation of the premises during the whole of said profits.
