Mortgagors shall (1) promptly repair, restore or rebuild any buildings or improvements now or hereafter on the premises which may become damaged edestroyed; (2) keep said premises in good condition and repair, without waste, and free from mechanic's or other lieus or claims for lieu not expressly dinated to the lieu hereof; (3) pay when due any indistrictions which may be secured by a lieu or clarge on the premises superior to the lieu hereof, and require schild statisfactory evidence of the discharge of such prior hen to Trustee or to holders of the note; (4) complete within a reasonable time any ling or buildings now or at any time in process of erection upon said premises; (5) comply with all requirements of law or immicipal ordinates with cet to the premises and the use thereof; (6) make no material alterations in said premises except as required by law or municipal ordinates, with the charges against the premises when due, and shall, upon written request, furnish to Trustee or to holders of the note duplicate receipts therefore, to not default hereunder Mortgagors shall pay in full under protest, in the manner provided by statute, any tax or assessment which Mortgagors may desire mixes.
