



 Cook and State of Illinois, to wit:

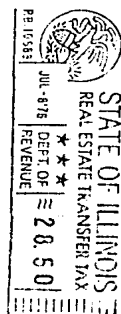
