THIS INDENTURE, made this 8th day of June, 1976, between CHICAGO TITLE AND TRUST COMPANY, a corporation of Illinois, as Trustee under the provisions of a deed or deeds in trust, duly recorded and delivered to said company in pursuance of a trust agreement dated the 29th day of September, 1975 and known as Trust Number 1066833 party of the first part, and Harold Freeman and Alice Freeman, his wife, of 10015 Beverly Drive, Skokie, Illinois not as tenants in common, but as joint tenants, parties of the second part. WITNESSETH, that said party of the first part, in consideration of the sum of TEN & NO/100 (\$10.00) ----- dollars, and other good and valuable considerations in hand paid, does hereby grant, sell and convey unto said parties of the second part, not as tenants in common, but as joint tenants, the following described real estate, situated in Cook County, Illinois, to-wit:

Unit No. 303, as delineated upon Survey of Lots 37 to 44, inclusive, and Lots 53 to 58, inclusive (except from said Lots that part taken for roads, and except the East 11.20 feet of said Lot 44, and except the South 7 feet of Lots 53 to 55, inclusive and except the South 7 feet of Lot 58) in Old Orchard Resubdivision, a part of Lot 5 and all of Lot 6 of Administrator's Subdivision of the Northwest Fractional 1/4 of Fractional Section 10, Township 41 North, Range 13, East of the Third Principal Meridian, in Cook County, Illinois, which Survey is attached as Exhibit "A" to Declaration of Condominium made by Chicago Title and Trust Company, as Trustee, under Trust Agreement dated September 29, 1975, and known as Trust No. 1066833, recorded in the Office of the Recorder of Cook County, Illinois as Document No. 23510757, together with an undivided 2/301 interest in the property described in said Declaration of Condominium aforesaid (excepting the units as defined and set forth in the Declaration of Condominium and Survey), hereinafter "PROPERTY", together with the tenements and appurtenances thereunto belonging. TO HAVE AND TO HOLD the same unto parties of the second part forever, not in tenancy in common, but in joint tenancy, subject to: 1. General real estate taxes for the year 1976 and subsequent years; 2. General real estate taxes which may accrue by reason of new or added improvements during the year 1976; 3. Encroachment of the concrete wall located mainly on the property east and adjoining onto the PROPERTY by 20 feet; 4. Easements, building, building line use or occupancy restrictions, covenants and conditions or record; 5. Applicable zoning and building laws and ordinances; 6. Acts done or suffered by or judgments against parties of the second part or anyone claiming under them; 7. Condominium Property Act of Illinois; 8. The Old Orchard East Condominium Association Declaration of Condominium Ownership.

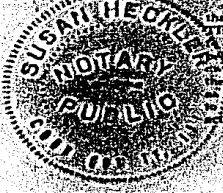
