To Have and to Hold the same unto said party of the second part forever as joint tenants and not as tenants in common.

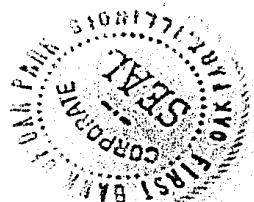

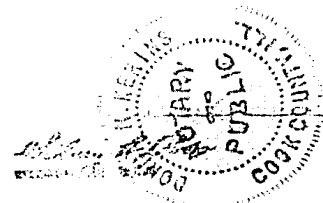
