<u>Instructions</u>: The following declaration must be filled out completely, signed by at least one of the grantees (purchasers), signed by at least one of the grantors (sellers), and presented to the Chicago Department of Revenue at the time of purchase of real property transfer stamps as required by the Chicago Transaction Tax Ordinance.

The full acture mount of consideration of the transaction is the amount upon which the tax is to be computed. Both the full actual consideration of the transaction and the amount or the tax stamps required must be stated on the declaration.

Any transaction involving the transfer of real property located in the City of Chicago is presumed to have been consummated in the City of Chicago for purposes of enforcing this tax.

Note: The Chicago Transaction Tax Ordinance specifically exempts certain transactions from taxation. These exemptions are enumerated in Sections 200.1-286 and 200.1-4B. To claim one of these exemptions, a separate declaration form must be executed and filed with the Recorder of Deeds. Forms may be obtained from the Chicago Department of Revenue, Room 107 - City Hall.
