ELROD, SHERIFF OF COOK COUNTY, ILLINOIS, in consideration of the premises, DO HEREBY CONVEY to the said FRANK SKACH AND GEORGE B. 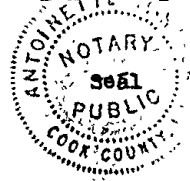
