THIS INDENTURE WITNESSETH, That the undersigned as grantors, of Chicago County of Cook
and State of Illinois for and in consideration of the sum of One Dollar and other good and valuable considerations, in hand paid,
convey and warrant to Geun S. Poik of Michigan City
County of La Porte and State of Indiana the following described Real Estate, with all improvements thereon, situated in the County of Cook in the State of Illinois to wit:
Lot 11 in Block 6 in Oliver Salinger and Company's Kimbell Boulevard Addition on to North Edgewater, a Subdivision of the North 1/2 of the North West 1/4 of the South East 1/4 and that part of the North 1/2 of the North East 1/4 of the South East 1/4 of Fractional Section 2, Township 40 North, Range 13, East of the Third Principal Meridian, lying West of the West Line of Right of Way of the North Shore Channel of Sanitary Distance of Chicago in Cook County, Illinois
hereby releasing and waiving all rights under and by virtue of the homestead exemption laws of the State of Illinois

GRANTORS AGREE to pay all taxes and assessments upon said property when due, to keep the buildings therein insured to their full insurable value, to pay all prior liens and the interest thereon and to keep the property tenable and in good repair and free of liens. In the event of failure of Grantors to comply with any of the above covenants, then grantee is authorized to attend to the same and pay the bills therefor, which shall with the interest thereon, become due immediately, without demand. On default in any payments hereunder, grantee may declare the whole indebtedness due and proceed accordingly.

AS FURTHER SECURITY grantors hereby assign, transfer and set over to grantee all the rents, issues and profits of said premises, from and after this date, and authorize him to sue for, collect and receive for the same, to serve all necessary notices and demands, to bring forcible detainer proceedings to recover possession thereof, to repossess the said premises as he may deem proper and to apply the money so arising to the payment of this indebtedness, or to any advancements made as aforesaid, and it shall not be the duty of grantee to inquire into the validity of any such taxes, assessments, liens, encumbrances, interest or advancements.

In trust, nevertheless, for the purpose of securing performance of the following obligation, to-wit:

Two years Geun S. Poik

The sum of Fifteen thousand and no/100 \$15,000.00 Dollars
At the office of the legal holder of this instrument with no interest
And to secure the payment of said amount I hereby authorize, irrevocably, my attorney of record in any County or State in the United States to appear for me in such court, at term time or vacation, at any time hereafter had and/or a judgment without process in favor of the holder of this instrument for said amount as may appear to be unpaid thereon, together with costs, and Twenty-five Dollars Attorney's fees, and to waive and release all costs which may otherwise be any such proceedings, and consent to immediate execution upon such judgment, hereby ratifying and confirming all that my (our) said attorney may do by virtue hereof.

IN THE EVENT of the death, inability, removal or absence from said Cook County of the Trustee, or of his refusal or failure to act, then George Kito of said County, is hereby appointed to be the said Trustee, is hereby appointed to be the said successor in this trust; and if for any like cause the successor fail or refuse to act, the person who shall then be the acting Recorder of Deeds of said County is hereby appointed to be second successor in this trust. And where all the aforesaid covenants and agreements are performed the trustee, or his successor in trust, shall release the premises to the party entitled thereto on receiving his reasonable charges.
