This deed is given on the conditional limitation that the percentage of ownership of said Grantees in the Common Elements shall be divested pro tanto and vest in the Grantees of the other units in accordance with the terms of said Declaration and any Amended Declarations recorded pursuant there'o, and right of revocation is also hereby reserved to the Grantor herein to accomplish this result. The acceptance of this conveyance by the Grantees shall be deemed an agreement within the contemplation of the Condominium Figure 14 Act of the State of Illinois to a shifting of the Common Elements pursuant to said Declaration and to all the officer ferms of said Declaration, which is hereby incorporated herein by reference thereto, and to all the terms of such Amended Declaration pursuant thereto.

Party of the first part also hereby grants to parties of the second part, their successor, and assigns, as rights and easements appurtenant to the above described real estate, the rights and easements for the bei efit of said property set forth in the aforementioned Declaration, and party of the first part reserves to itself, its st corresors and assigns, the rights and easements set forth in said Declaration for the benefit of the remaining proper y described therein.

This Deed is subject to all rights, easements, restrictions, conditions, covenants and reservations contained in said Declaration the same as though the provisions of said Declaration were recited and stipulated at length herein together with the tenements and appurtenances thereunto belonging.

TO HAVE AND TO HOLD the same unto said party of the second part not in tenancy in common, but in joint tenancy, as aforesaid and to the proper use, benefit and behoof of said party of the second part forever.

This deed is executed pursuant to and in the exercise of the power and authority granted to and vested in said trustee by the terms of said deed or deeds in trust delivered to said trustee in pursuance of the trust agreement above mentioned. This deed is made subject to the hen of every trust deed or mortgage (if any there be) of record in said county affecting the said real estate or any part thereof given to secure the payment of money and remaining unreleased at the date of the delivery hereof.
