Subject to: Taxes for 1976 and subsequent years and easements of record.

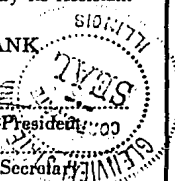

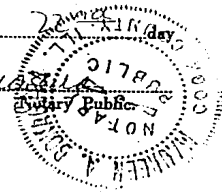
