The holder and owner of said <sup>(1)</sup> Trust Deed, and the note secured thereby, has consented and agreed to subordinate the lien created by said <sup>(1)</sup> Trust Deed to that of a certain <sup>(1)</sup> Trust Deed bearing the date of the 18th day of October, 1976, and recorded in the office of the Recorder of Deeds of Cook County, Illinois, as Document No. 23 700 602.

Now, therefore, in consideration of the sum of One (\$1.00)-----Dollars, the receipt of which is hereby acknowledged, the said holder and owner of said <sup>(1)</sup> Trust Deed, recorded as Document No. 22138137 covenants and agrees that the aforesaid <sup>(1)</sup> Trust Deed and for and on behalf of the legal holder of the note secured thereby, shall be and shall remain subordinate and inferior as a lien against the aforesaid described real estate to the lien of the <sup>(1)</sup> Trust Deed recorded as Document No. 23 700 602 wherein Homewood Industries, Inc. is described therein as <sup>(3)</sup> Mortgagor.

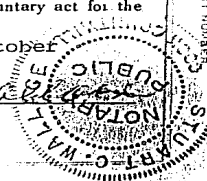
