in hand paid, and pursuant to authority given by the Board of Directors of said corporation  
CONVEYS and WARRANTS unto Shirley M. Karas, 901 Linden Court,  
of the Village of Western Springs in the County of Cook and State of  
Illinois the following described Real Estate situated in the County of  
Cook in the State of Illinois, to wit: See attached legal description

Unit 502-#2, as delineated on Plat of Survey of the following described parcel of real estate: That part of the Northwest 1/4 of Section 17 and that part of the Northeast 1/4 of Section 18, Township 38 North, Range 12 East of the Third Principal Meridian, described as follows: Commencing at the Northeast corner of the South 1/2 of the Northeast 1/4 of said Section 18; thence South on the East line of said Section 18, 450.50 feet; thence West parallel with the North line of the South 1/2 of the Northeast 1/4 of said Section 18, 111.00 feet; thence South at right angles to the last described line 92.00 feet; thence East parallel with the North line of the South 1/2 of the Northeast 1/4 of said Section 18, 59.40 feet to the place of beginning; thence continuing East along said parallel line 141.33 feet to the center line of Wolf Road; thence Southerly along the center line of said Wolf Road, 153.19 feet; thence West parallel with the North line of the South 1/2 of the Northeast 1/4 of said Section 18, 162.53 feet; thence North at right angles to the last described line, 152.12 feet to the place of beginning, in Cook County, Illinois; which Plat of Survey is attached as EXHIBIT "B" to Declaration of Condominium made by Pullman Bank and Trust Company, a corporation of Illinois, as Trustee under Trust Agreement dated July 9, 1963, and known as Trust No. 71-80632, recorded in the office of the Recorder of Deeds of Cook County, Illinois as Document No. 23407018; together with a percentage of the Common Elements appurtenant to said Unit as set forth in said Declaration, as amended from time to time, which percentage shall automatically change in accordance with Amended Declarations as same are filed of record pursuant to said Declaration, and together with additional Common Elements as such Amended Declarations are filed of record, in the percentages set forth in such Amended Declarations, which percentages shall automatically be deemed to be conveyed effective on the recording of each such Amended Declaration as though conveyed hereby.

This deed is conveyed on the conditional limitation that the percentage of ownership of said Grantees in the Common Elements shall be divested pro tanto and vest in the Grantees of the other Units in accordance with the terms of said Declaration and any Amended Declarations recorded pursuant thereto, and the right of revocation is also hereby reserved to the Grantor herein to accomplish this result. The acceptance of this conveyance by the Grantees shall be deemed an agreement within the contemplation of the Condominium Property Act of the State of Illinois to a shifting of the Common Elements pursuant to said Declaration and to all the other terms of said Declaration, which is hereby incorporated herein by reference thereto, and to all the terms of each Amended Declaration recorded pursuant thereto.

Grantor also hereby grants to the Grantees, their heirs and assigns, as rights and easements appurtenant to the above described real estate, the rights and easements for the benefit of the property set forth in the aforementioned Declaration, and Grantor reserves to itself, its successors and assigns the rights and easements set forth in said Declaration for the benefit of the remaining property described therein.

This Deed is subject to all rights, easements, restrictions, conditions, covenants and reservations contained in the said Declaration the same as though the provisions of said Declaration were recited and stipulated at length herein.
