for the benefit of the remaining property described therein.

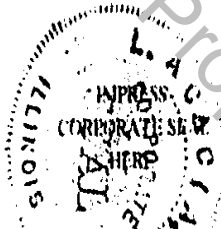

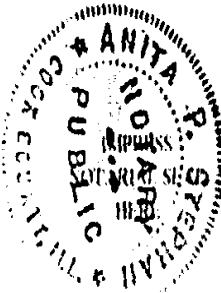
