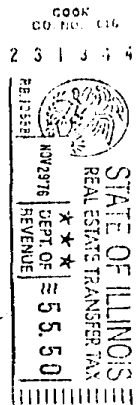
This Indenture, Made this 29th day of June A. D. 1976, by and between

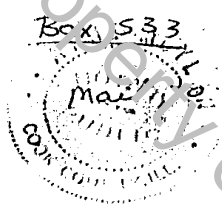
