TO HAVE AND TO HOLD the same unto said party of the second part, and to the proper heirs, use, benefit and behoof forever of said party of the second part.

Subject to all liens and encumbrances of record, if any.

This deed is executed pursuant to and in the exercise of the power and authority granted to and vested in said trustee by the terms of said deed or deeds in trust delivered to said trustee in pursuance of the trust agreement above mentioned. 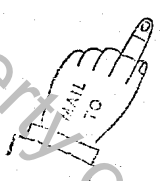
