WITNESSETH, that said party of the first part, in consideration of the sum of TEN DOLLARS Dollars, (\$ 10.00) and other good and valuable considerations in hand paid, does hereby grant, sell and convey unto said parties of the second part, not as tenants in common, but as joint tenants, the following described real estate, situated in Cook County, Illinois, to-wit:

Lot number 10 in Frenchmen's Cove Unit Two, a subdivision of part of the West 1/2 of the Northeast 1/4 of section 8, Township 42 North, Range II, East of the 3rd principal meridian, in Cook County, Illinois.

Subject to: (1) real estate taxes for the current and subsequent years; (2) easements, covenants and restrictions and building lines of record; (3) zoning and building laws or ordinances; (4) Grantee's mortgage if any; (5) acts done or suffered by Grantee; and (6) special taxes or assessments for improvements not yet completed;

together with the tenements and appurtenances thereunto belonging.

TO HAVE AND TO HOLD the same unto said parties of the second part not in tenancy in common, but in joint tenancy, and to the proper use, benefit and behoof of said parties of the second part forever.

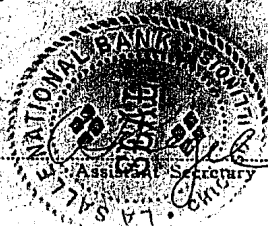

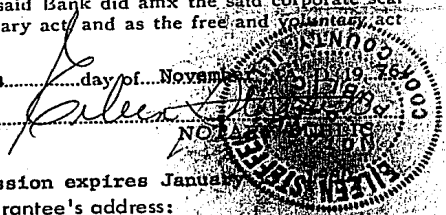
