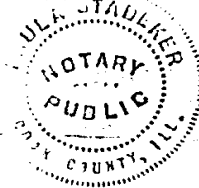

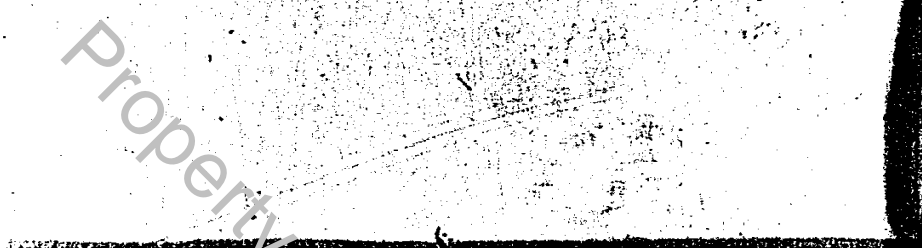


Unit No. 11B as delineated on survey of the following described parcel of real estate (hereinafter referred to as "Parcel"):
